Reunion, reunion, reunion!! Come one, come all, it will be a grand time. We have a wonderful committee representing the various living groups, who will make sure everyone is treated special.

We have had an amazing 50 years – from JFK, the moon landing, Vietnam, inflation, recession, varied careers, failures and successes, kids and grandkids, marriages, financial meltdowns, counting chads, to our current dilemma in the middle east and those are just a few of the events shaping our lives. We have gone to cellphones and emails for staying in touch. Some of us have moved into texting, Facebook and maybe a few into Twitter. We have moved from an analog world into a digital world without missing a step or maybe missing a half-step. Where does it end? Simply amazing.

Any reunion, but especially the 50<sup>th</sup>'s first priority is to get everyone to attend. Another priority is for our class to consider making meaningful gifts to honor the contribution Whitman has made in our lives. So here we are, hat in hand, asking you to make a gift or a pledge to support Whitman College. Multiple year pledges count towards our class gift.

Besides writing a check, there are many ways to say thanks and support Whitman's future work. A percentage in your will is a great way to give back. Say 5% or a number that won't have to be funded until your train leaves the station. Another great way is a Charitable Gift Annuity. With interest rates low and looking like they may stay there a while, consider a \$10,000 or more Charitable Gift Annuity. A portion of the gift is treated as a charitable contribution, a portion of the income, about 80%, is treated as tax-free, and you don't pay a commission or on-going expenses like traditional annuities. Our numbers are close but not exact. The payout, depending on one or two lives, is in the 4.5% - 5.5% range but we can get more specific if this interests you. Whitman has an expert, Jamie Kennedy, Director of Gift Planning, who can detail what this would look like for you. He is a "no-pressure" resource who will be sending additional information, which covers various giving options. There are lots of ideas to fill up your time when you come here in May. First, plan on staying Sunday so you can march in the commencement processional. 
