## 5. OLD BUSINESS.

a. Revisit idling policy and discuss requested revisions: The committee revisited the Idling policy adopted on February 24, 2017. The original policy was rejected due to enforceability issues. The plan calls for a 90% waste diversion rate by 2030. The committee discussed the plan and certain strategies of the plan. The committee voted to endorse the ASWC Zero Waste Plan unanimously. The committee requested some minor corrections to the document.
