## **CONVICTION/CRIMINAL HISTORY INFORMATION**

The Washington State Child and Adult Abuse Information Law (RCW 43.43.830-.842) requires that employers ask applicants to disclose specific information about any convictions for crimes against persons and crimes relating to financial exploitation and findings in related actions and proceedings. This conviction information must be disclosed before an applicant can be considered for employment in any position which may involve unsupervised access to children, developmentally disabled persons or vulnerable adults as defined by the law. A conviction/criminal history record does not necessarily disqualify an individual for employment. Criminal history records may be verified through the Washington State Patrol and other law enforcement related agencies. Initial and/or continued employment may be subject to a satisfactory Criminal Conviction Report. When a criminal history inquiry is conducted, the applicant is notified of the inquiry in advance and must sign a separate release form. Questions about the use of conviction/criminal history information in the application process may be referred to the Human Resources Department. A copy of any response received pursuant to such inquiry will be made available to you upon request.
